- 1. Triumph Public High Schools will reach out to all parents and family members and implement programs, activities, and procedures for the involvement of parents and family members in programs consistent with the requirements of ESSA Section 1116. Such programs, activities, and procedures shall be planned and implemented with meaningful consultation with parents of participating children. <u>Section 1116 (a)(1)</u>
 - <u>School-Parent Compacts:</u> Families and parents will be involved in the creation and annual revisions of the School-Parent Compact.
 - <u>Parent/Student Orientations:</u> All parents and students enrolling in the district are required to attend an orientation to review educational and behavioral expectations including the Student Handbook and the Student Code of Conduct. This will also include opportunities for parents and students to ask questions and share information about students and school resources.
 - <u>Beginning of the Year Open House/Meet the Teacher:</u> A period of time prior to the first day of instruction or within the first three weeks of the new academic year a time will be set aside where families, parents/guardians, and students visit their school to meet school administration, teachers, and staff.
 - Three Quarterly Report Card Nights: An afterschool event set by each campus where parents come
 to school to get student report cards and have opportunities to discuss individual students'
 academic/educational progress. These events will be held at the close of each 9-week reporting
 cycle.
 - <u>College and Career Fair:</u> An opportunity for parents and students to visit the campus and interact
 with various college, university, and career booths to gather information and discuss post-secondary
 opportunities.
 - <u>Student Celebrations:</u> Campus specific opportunities where families, parents, and students are invited to celebrate student achievement and success. Potential activities include "A" Honor Roll, "A/B" Honor Roll, Perfect Attendance, Student of the Month, and Awards Banquets. Campuses can add additional activities that celebrate student success.
 - <u>Student & Parent Participation on Committees:</u> There are multiple opportunities through District Leadership Teams (DLT), Campus Leadership Teams (CLT) and Parent Engagement/Advisory Committees for students and parents to provide feedback and input on continuous improvement of the district.
 - <u>Post-Secondary Readiness</u>, FAFSA/Financial Planning and Graduation Meetings: Various events to
 focus student on opportunities for college, career and military options and resources in the district.
 This will include options for AP, Career and Technical coursework, and dual-credit opportunities.
 Federal Application for Financial Student Assistance (FAFSA) application support will be a focus in
 this area.
 - Parent-Teacher Conferences, Phone Calls and Electronic Communication: Parents and families can request parent-teacher conferences to discuss student progress at any time by contacting the teacher or the campus principal. Parents and families can reach school personnel by phone or electronic mail to request a visit.
 - <u>Family, Parent and Community Learning Opportunities:</u> Learning opportunities for parents will be prepared twice a year (once each semester) on how parents can effectively engage in their students' education as young adults. Learning opportunity requests are encouraged from families and parents.
 - <u>School Messenger/Messaging System:</u> The district will utilize "School Messenger" to provide realtime feedback via phone/text messaging. The messaging system will provide updates and feedback for upcoming events activities.
 - <u>Parent Newsletters:</u> Quarterly "Parent and Family Engagement Connection" newsletter prepared by TEA and Region 16 Education Service Center will be provided to parents quarterly through availability at the campus and on the <u>Triumph Public High Schools website</u>.
 - <u>Parent and Family Volunteers:</u> Parent and families are invited and encouraged to engage with district and campus level community service projects, accompany the school on field trips, and assist teachers. To find out how to become a volunteer, reach out to your school's principal.
- 2. Triumph Public High Schools receives Title I, Part A funds. Our goal is to plan and implement effective parent

and family involvement activities to improve student academic and school performance. Therefore, Triumph Public High Schools will develop jointly with, agree on with, and distribute to, parents and family members of participating children a written parent and family engagement policy. - Families, parents, and students will be invited to participate and provide input to the District and Campus Improvement Plans.
- Family and parent questions and comments are encouraged via email, phone, social media resources, and face-to-face communication.
- 3. Triumph Public High Schools will involve parents and family members in jointly developing the local educational agency plan (DIP) under section 1112, and the development of support and improvement plans under paragraphs (1) and (2) section 111(d). <u>Section 1115 (a)(2)(A)</u>
 - The District Improvement Plan (DIP) and Campus Improvement Plans (CIPs) are reviewed, revised, and updated on an annual basis beginning in the Spring semester of each academic year. Families, parents, and students are invited and encouraged to participate in the leadership committees in designating action plans to meet the district mission, vision, and academic goals.
- 4. Triumph Public High Schools will provide the coordination, technical assistance, and other support necessary to assist and build the capacity of all participating schools within the local educational agency, in planning and implementing effective parent and family involvement activities to improve student academic achievement and school performance, which may include meaningful consultation with employers, business leaders, and philanthropic organizations, or individuals with expertise in effectively engaging parents and family members in education.  - The Regional Educational Service Center parent involvement staff provide coordination and technical assistance. Resources and technical assistance will also be accessed from Region 16 Education Service Center's Title I, Part A Parent and Family Engagement Statewide Initiative resources website. Parent and Family Engagement activities are coordinated with counselors, parent liaisons, CCMR coordinators, district and campus staff, and local community/family vendors.
- 5. Triumph Public Schools will coordinate and integrate parent and family engagement strategies under Title I, part A, to the extent feasible and appropriate, with other relevant Federal, State, and local laws and programs, including public preschool programs, and conduct other activities such as parent resource centers, that encourage and support parents in more fully participating in the education of their children. <u>Section 1116(a)(2)(C) & Section 1116(e)(4)</u>
 - <u>College & Career Fair:</u> College and career fairs bring in colleges, universities, technical schools, and various career vendors for students and families to engage with regarding post-secondary readiness opportunities
 - <u>Student Celebrations:</u> These are opportunities to engage with the community to provide encouragement and support through philanthropic giving to support students and famukues for individual success.
 - <u>Post-Secondary Readiness</u>, <u>FAFSA/Financial Planning and Graduation Meetings</u>: These opportunities provide opportunities for campuses, colleges, financial aid organizations and graduation service vendors to collaborate and prepare for celebration and next steps after graduation.

- 6. Triumph Public High Schools will conduct, with the meaningful involvement of parents and family members, an annual evaluation of the content and effectiveness of the parent and family engagement policy in improving the academic quality of all schools served under this part, including identifying <u>Section 1116 (a)(2)(D)</u>
 - barriers to greater participation by parents in activities authorized by this section (with particular attention to parents who are economically disadvantaged, are disabled, have limited English proficiency, have limited literacy, or are of any racial or ethnic minority background);

 - Parents and families are invited and encouraged to participate in the meaningful review and revision
 of the Parent and Family Engagement policy on an annual basis. Parent and family feedback will be
 gathered through attending a series of face-to-face meetings at various times to allow working families
 to participate or they can submit survey responses both digitally or hard copy. Language translation
 will be provided during meetings and surveys will be given in parents and families native language.
 Disability accommodations will be made for parents and families need them.
 - In the Parent and Family Engagement review process, the Triumph Public High Schools mission and vision will be discussed and what the academic targets have been established.
 - The Parent and Family Engagement review process will determine what specific needs and barriers
 exist to engaging with school personnel and ensuring their children are meeting learning targets and
 supporting successful school and family interactions.
 - The Parent and Family Engagement review process is conducted in April/May of each academic year.
 The District Level Parent Involvement Coordinator and the Campus Principal will be responsible for
 conducting the Parent and Family Engagement review process. Findings will be communicated
 through revisions and adjustments in the policy. Updates to the policy will be reflected on the Triumph
 Public High Schools website and in hard copy format at each campus.
- 7. Triumph Public High Schools will use the findings of such evaluation to design evidence-based strategies for more effective parental involvement, and to revise, if necessary, the parent and family engagement policies; and Section 1116 (a)(2)(E)
 - The role of parents and families will be to use resources and technical assistance from Regional Education Service Centers and the Region 16 Statewide Parent Engagement Initiative to choose and design effective evidence-based strategies for improving and growing parent and family engagement. District and campuses will leverage staff members to implement strategies and systems along with associated professional development to ensure fidelity of implementation.
- 8.  - Curriculum and supplementary services will be provided and communicated to the parents and families to ensure students have necessary recourses o meet rigorous State standards. Any technology needs will be requested by the parent to the campus principal.
- (iii) educating teachers, specialized instructional support personnel, principals, and other school leaders, and other staff, with the assistance of parents, in the value and utility of contributions of parents, and in how to reach out to, communicate with, and work with parents as equal partners, implement and coordinate parent program, and build ties between parents and the school; <u>Section 1116 (e)(3)</u>
